("Harm")
 I AGREE to release the Competition from all claims for money damage or otherwise from any Harm to me or my horse or to others, even if the Harm resulted, directly or indirectly, from negligence of the Competition.
 I AGREE to expressly assume all risks of Harm to me or my horse, including Harm resulting from from the negligence of the Competition.
 I AGREE to indemnify (that is to pay any losses, damages or cost incurred) by the Competition and to hold harmless in respect to vlain for Harm to me or my horse and for claims made by others for Harms caused by me or my horse at the competition.
 I have read the rules about protecve equipment and I understand I am entitled to wear protective equipment without penalty, and I acknowledge that the Competition Strongly Encourages me to do so while WARNING that no protective equipment can guard against all injuries. If I am a parent or guardian of a junior exhibitor, I consent to the child's participation and AGREE to all of the above provisions and AGREE to assume the entire obligation of this Release on the child's behalf.
